- Where:** Warfield Point Park, 295 Warfield Point Park Greenville, Mississippi 38701  
(do not mail applications here)
- When:** Thursday, October 11 - 13, 2018  
Begins on Thursday, September 28 at 8 a.m. If vending on Thursday, you must be setup by Thursday at 5:00 p.m. The festival begins on Thursday at 5 with a Singer/ Songwriter competition.
- Necessary inspections will begin at 12:30 p.m. MS Department of Health will inspect, and you are required to pay \$100 for this.
- Deadline:** Application **MUST** be received by September 1, 2018.
- Vendor Space:** Vendors must have a tent/truck with a good roof that can withstand wind, rain and other inclement weather. Come prepared for all types of weather. You must secure your booth in case of windy conditions. All items being sold must be contained in booth space.
- Electricity:** Vendors **MUST** list all electrical connections on application (NO EXCEPTIONS!). Electrical arrangements must be made prior to your arrival. 15 amp/110 volt only. Last minute electrical changes **WILL NOT** be accepted.
- Weather:** The festival will not be cancelled because of rain. This is an outdoor event; be prepared for any type of weather. Tents, canopies and pop-ups must be secured to withstand weather.
- Insurance Requirements:** A current Certificate of Insurance is required for all vendors naming Mighty MS Music Festival/ Downriver Entertainment as the additional insured. Certificate of Insurance is required one week before festival. Your current insurance provider will be able to complete this for you.
- The exhibitor will be responsible to be open during the entire festival. You cannot vacate early. Your area must be neat, attractive and well-maintained. Signage with visible and item pricing is required. You are responsible for setting up, maintaining and removing your own booth, merchandise and trash. The MS Department of Health will inspect your booth before the festival. When your booth is inspected, you must pay the MS Department of Health a fee of \$100. You are **required** to complete a Mississippi Sales Tax Form at the end of the festival and make a payment. If a Sales Tax form is not complete, you will not be allowed to return to the 2018 festival.

**You May Not Sell Beverages, Snow Cones, Funnel Cakes.  
You will be asked to leave if you sell these items.**
